WHAT IS IT?

Cyprus Flight Pass is a dedicated portal of the Republic of Cyprus that aims to facilitate your travel arrangements to Cyprus and ensure the capture of all necessary information required by the Health authorities. You can complete all the necessary formalities in a quick and easy way and receive your authorization to fly.

APPLICATION PROCESS

In order to support the containment of COVID-19 in Cyprus all inbound passengers are required to present a 'flight pass' to fly prior to boarding.

The requirements defined by the Ministry of Health are dependent on a number of factors about you and your visit.

To receive a CyprusFlightPass* each passenger will need to:

1. Create an account
2. Enter personal information
3. Add your flight details
4. Make legal declarations

(You may be required to provide evidence of a negative COVID-19 test)

In the case of minors accompanied or unaccompanied passengers under the age of 18, the Information will be provided and the form will be completed and signed on behalf of the minors, by the custodian parent (s) or the adoptive parent (s) / legal guardian (s) / legal representative(s)

On successful completion of your application you will receive a report including your CyprusFlightPass and all relevant information which you will be asked to present prior to boarding and on arrival at immigration.

* Passengers travelling to the Republic of Cyprus from a country not included in Categories Green or Orange or Red, are required to obtain beforehand a special permit. Read more

Prerequisites and Download Forms

In the case where the web electronic platform of the Republic of Cyprus is temporarily unavailable due to technical issues or scheduled maintenance with official announcement about that, in the relevant electronic platform you are required to print and complete the relevant documents found [here](#).

From countries (<https://cyprusflightpass.gov.cy/en/country-categories>), where travelers are required to conduct a laboratory test for COVID-19, performed by a certified laboratory during the last 72 hours before their trip to the Republic of Cyprus, they also have to carry with them and present the documents proving the negative PCR results for COVID-19, which clearly record the date and time of the examination (the sampling for the COVID-19 test is required to be conducted during the last 72 hours before departure).

SPECIAL PERMISSION (For Country Category “GREY”)

Applications for special permission cannot be submitted in the last 2 days prior to the expected travel date.

Please submit your applications early enough to avoid disappointment.

(Excluding aircraft crews, in cases where they are travelling as passengers for replacement purposes and seafarers)

Passengers, with nationality of third countries, travelling to the Republic of Cyprus from a country not included in Categories **Green**, **Orange**, **Red** are required to obtain beforehand a special permit as defined by the Infectious Diseases (Determination of Measures to Prevent the Spread of the COVID-19 Coronavirus) Decree (No. 9) of 2021, as amended for the time being.

Exempt from this obligation are the following persons:

1. Cypriot citizens and members of their families (their alien spouses and under-age)
2. Persons legally residing in the Republic
3. Persons entitled to enter the Republic under the Vienna Convention
4. European citizens, citizens of the European Economic Area (Iceland, Norway, Liechtenstein) and Switzerland



Passengers' applications for the granting of a Special Entry Permit must be submitted on line as of 04/08/2020 through the platform following the link <https://cyprusflightpass.gov.cy/en/special-permission-request>

It is emphasized that the obtaining of a Special Entry Permit to the Republic of Cyprus applies only to persons, with nationality of third Countries, travelling from countries not included in the Categories in Categories Green, Orange, Red, in accordance with the categorization of countries as announced by the Ministry of Health, and shall be granted only in the following cases:

1. First degree relatives of persons who reside legally in the Republic and/or are economically active in the Republic (spouse, children, parents) for family reunion purposes
2. Persons whose arrival in the Republic is necessary for the purpose of implementing public projects or for honoring other important professional commitments
3. Domestic Workers or Workers that have already been granted an approval for any other work in the Republic by the competent Ministry or Department - [Learn more](#)
4. Workers in Agriculture and Livestock field - [Learn more](#)
5. Athletes/ Referees/ Supporting personnel, participating in professional sport activities and for Athletic Reasons
6. Changes of aircraft crews in the case where they are travelling as passengers for replacement purposes
7. Seafarers for the purpose of crew change or repatriation

Requests for the granting of a special permit may be submitted through the e-platform within 14 days prior to the expected travel date. As from 1st of April 2021, the approval granted shall be valid for two months since the date of issue. Special Permissions that have already been approved prior to 1st of April 2021, the approval granted shall be valid for a month since the date of issue.

Upon the granting of the special permit a unique number will be sent exclusively connected to the passenger's identity card number or passport number.

The passenger would then be able to use the said number in filling out his/her application for acquiring a CyprusFlightPass, by writing it down in the required space as special permit number.



With respect to requests for aircraft crew changes and seamen these shall be submitted to and become accepted ONLY by ground handling service providers and agents and must contain, amongst other, the following additional details:

Name of Ground Handling Service Providers and Airline Company Name or Aircraft Registration Number in the case of a private flight by which the crew members are employed

Ship's name and Agent's Details: (Name, Surname, Agent's company, contact number)

LEGAL DECLARATIONS

Legal Declarations

In order to receive a CyprusFlightPass you will be required to complete the following declarations:

1. I consent for possible COVID-19 sample testing, if requested, upon arrival to the Republic of Cyprus (Persons allowed to enter in the Republic of Cyprus under the Vienna Convention of 1961 and 1963 are exempted).
2. I am fully aware of the risks, dangers and hazards connected to my flight and stay in the Republic of Cyprus, due to the COVID-19 pandemic. I assume and accept full responsibility for any risks of loss, harm, property damage or personal injury or death and I agree not to make claim and take proceedings against any person and/or any kind of businesses and/or authorized officers and /or the authorities of the Republic of Cyprus from any loss, liability, damages or costs that I may sustained and/or costs that I may incurred during my travel and stay to the Republic of Cyprus, as a result to COVID-19 and/or for any inconvenience I will be suffered, due to any precautionary measures applied during my trip and my stay in the Republic of Cyprus, for the purposes of protection of public health against COVID-19. This waiver of Liability, shall be binding to my family members members and spouse and my heirs, assigns and personal representative, executors and successors.
3. Following my return to my country of permanent residence, or to the country to which I return following the completion of my trip to the Republic of Cyprus, I shall inform the Medical Services of the Republic of Cyprus in the case I have developed symptoms of COVID-19, within 14 days following my departure from the Republic of Cyprus (e-mail address for correspondence monada@mphs.moh.gov.cy).
4. I have not experienced one of the following symptoms – fever, cough, fatigue, headache, muscle or body aches, loss of taste or smell, shortness of breath or difficulty breathing, sore throat,

congestion or runny nose, within the last 14 days or I have not been in close contact with a COVID-19 confirmed case.

5. I have not stayed/lived in countries with less favourable epidemiological criteria compared to the country of departure within the past 14 days before my departure to the Republic of Cyprus and/or I am not a passenger on an international journey to the Republic of Cyprus via intermediate Countries with an overnight stay(s) with less favourable epidemiological criteria compared to the country of departure, as per relevant Country categorization announcement of the Republic of Cyprus.
6. I declare subject to sanctions under the laws of the Republic of Cyprus that the facts and information I have provided, are complete, correct and true.

In the case of minors accompanied or unaccompanied passengers under the age of 18, the following Declaration will be completed on behalf of the minors, by the custodian parent(s) or the adoptive parent(s) / legal guardian(s) / legal representative(s):

7. I/We solemnly declare and affirm that all Information and Declarations given in respect of the child in this application is true. I/We have full knowledge and consent to the submission of this application of the child. I/We make this SOLEMN DECLARATION conscientiously and with the knowledge that making a false and/or misleading declaration, will be subject to sanctions under the laws of the Republic of Cyprus

In the case of passengers from Category Orange countries, the following Declaration will be additionally completed

8. I am aware and accept that, in case I belong to at least one of following passenger categories:
 - Cypriot citizens and their family members (foreign spouses and their minor children).
 - Persons legally residing in the Republic of Cyprus.
 - Persons allowed to enter in the Republic of Cyprus under the Vienna Convention.
 - Persons, in countries category Orange, where the authorities of these countries, are not in a position to offer COVID-19 testing to those wishing to travel to the Republic of Cyprus and following an announcement by the Ministry of Health of the Republic of Cyprus, passengers of these Countries are permitted to perform the COVID-19 test upon their entry to the Republic of Cyprus,

who have been granted the option of having the COVID-19 test performed upon entry to the Republic of Cyprus, I will personally pay the cost of the COVID-19 laboratory test, in case I have chosen to perform the COVID-19 laboratory test, upon my entry into the Republic of Cyprus.

In the case of passengers from Category Red countries, the following Declarations will be additionally completed:

9. I am aware and accept that I have to perform a second COVID-19 test upon my entry to the Republic of Cyprus and I will personally pay the cost of this second COVID-19 test.
10. I am aware and accept that, in case I belong to at least one of following passenger categories who have been given the option to undergo only one COVID-19 laboratory test, upon arrival to the Republic of Cyprus:
 - Cypriot citizens and their family members (foreign spouses and their minor children).
 - Persons legally residing in the Republic of Cyprus.
 - Persons allowed to enter in the Republic of Cyprus under the Vienna Convention.

and I have chosen to undergo a COVID-19 test ONLY upon my entry into the Republic of Cyprus, I will personally pay the cost of this COVID-19 laboratory test, and following this, I must remain in a state of compulsory self-isolation, for 72 hours following my arrival and I must repeat a molecular test RT-PCR for COVID-19, upon completion of the 72 hours, at my own expense, and I will send the result of my laboratory test to the email address: monada@mphs.moh.gov.cy.

11. I am aware and I accept that the self-isolation will be terminated, provided that I will repeat a molecular test RT-PCR, 72 hours following my arrival and the result of the repeated laboratory test RT-PCR is negative.

In the case of passengers from Grey (Special Permission) Category countries, the following Declarations will be additionally completed:

12. I am aware and accept that I will be under compulsory self-isolation for 14 days, according to the instructions and the precautionary and self-protection measures of the Ministry of Health, regardless of whether the result of the COVID-19 laboratory test is negative, either at my residence or in case I do not have a residence in the Republic of Cyprus, at a place that will be indicated to me by the Republic of Cyprus or
13. I will be under compulsory self-isolation for 10 days, in case I will repeat a COVID-19 molecular test, on 10th day of my self-isolation, with a negative result, at my own expenses and the result of the laboratory test has been sent to the following electronic address: monada@mphs.moh.gov.cy according to the instructions and the precautionary and self-protection measures of the Ministry of Health.

14. I am aware and accept that, in case I belong to at least one of following passenger categories:

- Cypriot citizens and their family members (foreign spouses and their minor children).
- Persons legally residing in the Republic of Cyprus.
- Persons allowed to enter in the Republic of Cyprus under the Vienna Convention.
- Persons, with a nationality of third Country, having a special permission by the Republic of Cyprus Persons, as defined under the infectious Diseases (Determination of Measures Against the Spread of the COVID-19 Coronavirus disease) Decree (N.9) of 2021, as amended.

and I have chosen to undergo a COVID-19 test upon my entry into the Republic of Cyprus, I will personally pay the cost of this COVID-19 laboratory test, upon my entry into the Republic of Cyprus.

15. In the event that I have arrived at Larnaca and Pafos Airports from UK airports, I solemnly declare that I am aware of my obligations, as described below and the consequences of the Law in the event of my non-compliance, with effectiveness from 18:00 on 21st December 2020.

- I am aware and accept that I will be transferred to designated hotels in the Republic of Cyprus for a mandatory 7-day quarantine, unless I am under the age of 18 whereby I may choose to self-isolate at my residence. (People under the age of 18 have the choice to stay in the designated hotels, if they travel with their parents / guardians or, if they cannot, do the self-isolation at their residence).
- I am aware and I accept that on the 7th day of quarantine, I will undergo again a laboratory test and if the result is negative, I will continue, if I have a residence in the Republic of Cyprus, my self-isolation for 3 extra days (total days of isolation: 10) at my residence and I will be released on the 10th day provided that there are no Covid-19 symptoms.
- I am aware and I accept that If the test results are positive, I will remain in a state of mandatory isolation (quarantine), at a place that will be indicated to me by the Republic of Cyprus and I will follow the instructions, which will be given by the Ministry of Health.
